What is happening?

FIL Investment Management (Hong Kong) Limited as the Hong Kong Representative of Fidelity has advised us that the management of Fidelity is currently carried out through an investment management delegation arrangement, whereby the investment management functions are delegated by FIL Investment Management (Luxembourg) S.A., as the Management Company of the SFC-authorized Underlying Funds¹, to FIL Fund Management Limited ("**FFML**"). FFML may in turn sub-delegate investment management activities to the investment sub-managers listed in the Hong Kong Offering Documents.

FIL Investment Management (Hong Kong) Limited ("**FIMHK**")², being a corporation currently licensed by the SFC for type 9 regulated activity, acts as one of the investment sub-managers in respect of the sub-funds of Fidelity and is currently being delegated with the discretionary investment management function in respect of the Underlying Funds until further notice.
