#### What is happening?

We have been notified by JPMorgan Funds (Asia) Limited, as Hong Kong Representative of JPM, of certain changes to JPM and the Underlying Funds as below.

#### 1. Categorization of JPMorgan Funds - India Fund as Article 8 under SFDR

The Prospectus of JPM has been updated to reflect that JPMorgan Funds - India Fund has been re-categorized from Article 6 to Article 8 under SFDR.

The Underlying Fund has been classified as "ESG Promote" and the Sub-Fund Description in the Prospectus has been updated to reflect this categorization.

These updates clarify how the Underlying Fund is currently being managed and do not affect its risk profile.

### 2. Enhancement of disclosure and general updates

The Hong Kong Offering Documents have been updated to reflect the below:

- enhancement of benchmark disclosure of JPMorgan Funds Global Natural Resources Fund and JPMorgan Funds - Middle East, Africa and Emerging Europe Opportunities Fund; and
- other general updates.

The Hong Kong Offering Document of JPM and the Product Key Facts Statements of the relevant Underlying Funds have been revised to reflect the above updates and are available on their website am.jpmorgan.com/hk1.
