



Futura III Investment Choice Brochure

Important notes

- Futura III is an investment-linked assurance scheme ('ILAS") issued by Zurich International Life Limited ("Zurich", "we", "us").
- Your investments are subject to the credit risks of Zurich.
- Your return on investment choices linked to Futura III is calculated or determined by Zurich with reference to the performance of the underlying funds and is subject to the charges of the policy and therefore may be lower than the return of the corresponding SFC-authorized fund.
- The investment choices available under Futura III can have very different features and risk profiles; some may be of high risk. Please read the offering documents of Futura III and the offering documents of the underlying funds for details.
- You are not investing in the underlying funds of the investment choices. You do not have any rights or ownership over these underlying funds.
- The premiums paid by you towards the insurance policy will become part of the assets of Zurich. You do not have any rights or ownership over any of those assets. Your recourse is against Zurich only.
- This ILAS policy is designed to be held for a long-term period. Partial or full surrender of the policy, policy suspension or premium holiday may result in a significant loss of principal and/ or loyalty bonuses to be awarded. Poor performance of underlying funds may further magnify your investment losses, while all charges are still deductible.
- More importantly, you should be aware of the following regarding your death benefit and the cost of insurance:
- Part of the fees and charges you pay that will be deducted from the value of your policy will be used to cover the cost of insurance for the life coverage and any optional benefits you may choose.
- The cost of insurance will reduce the amount that may be applied towards investment in the underlying funds corresponding to the investment choices selected.
- The cost of insurance will increase significantly during the term of your policy due to factors such as age and investment losses, etc. This may result in significant or even total loss of your premiums paid.
- If the value of your policy becomes insufficient to cover all the ongoing fees and charges, including the cost of insurance, your policy may be terminated early and you could lose all your premiums paid and any benefits.
- You should consult your financial professional for details, such as how the charges may increase and could impact the value of your policy.

- Investment involves risk, you should not purchase the policy unless you understand it and it has been explained how it is suitable for you. The final decision is yours.
- You should be aware of the presence of an exchange rate risk due to the different currency between the underlying fund and the investment choice. The unit price of investment choice is calculated by utilising a daily currency exchange rate between the underlying fund currency and the investment choice currency. The currency exchange rate to be used is based on prevailing market rate and at the discretion of Zurich.

You should also read the offering documents of the underlying funds corresponding to the investment choices you are considering, which are made available by Zurich upon request. You can obtain these documents by calling our Customer Care Team on +852 3405 7150.

The investment choices are subject to an investment choice management charge of 0.75% per annum of the net asset value of the investment choices, which is payable to Zurich to cover accounting, reporting and administration costs of the investment choices. The investment choice management charges will be reflected in the unit prices of the investment choices.

The initial charges, redemption charges and switching charges (if applicable) detailed in the offering documents of the underlying funds which apply to transactions made directly in respect of the underlying funds are not applicable to the investment choices.

If dividends are declared and paid in respect of an underlying fund, Zurich will re-invest the dividends into the underlying fund in respect of which the dividends are declared. The dividend received will be reflected in the net asset value and unit price of such investment choice.

The units of the investment choices allocated to the policy are notional and are solely for the purpose of determining the value of the policy. You are not investing in the underlying funds and you shall not have any rights or ownership over the underlying funds. The return under the policy, subject to the charges of the policy, may be lower than the underlying funds.

Investment involves risk and the value of any investment and the income from it can fall as well as rise. Your investments in some investment choices may result in large and sudden falls in the price of units. The shortfalls on cancellation or loss on realization could be considerable, you may not get back the amount originally invested or you could get back nothing at all. Please remember that past performance is not a guide to future performance.
